THE DEALER AND MANUFACTURER ARE IGNORING MY COMPLAINTS. EVERY 10,000 MILES OR SO THE JEEP WILL WOBBLE SEVERELY WHEN BRAKES ARE APPLIED BECAUSE OF PREMATURE WARPING OF BRAKES/ROTORS/DRUMS AND DISCS. THE DESCRIPTIONS OF OTHERS ON YOUR WEB SITE ARE IDENTICAL TO THIS. *AK
