### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ORIGINAL INSTRUMENT CLUSTER WHICH WAS BACKLIT UNDER ALL RUNNING CONDITIONS NIGHT AND DAY WAS REPLACED W/ NON-BACKLIT CLUSTER DUE TO A SEPARATE FAILURE IN THE CLUSTER. UNLIKE OTHER CARS, THIS CLUSTER HAS NO LUMINESCENT MATERIAL ON THE INSTRUMENT FACE TO MAKE INSTRUMENTS READABLE UNDER DIFFICULT LIGHTING CONDITIONS; WITH BACKLIGHTING IT IS NO PROBLEM. WITHOUT IT IS DIFFICULT TO SEE AND DANGEROUS WHEN UNDER TREES, IN SHADE, WITH SUN AT CERTAIN ANGLES, ETC. THE BACKLIT CLUSTER WAS REPLACED DUE TO A SEPARATE FAILURE AND MANUFACTURER AND REPAIRING DEALER STATE BACKLIT VERSION IS NO LONGER AVAILABLE DUE TO A RUNNING CHANGE IN MANUFACTURING. I HAVE HEARD IT RUMORED VARIOUSLY THIS WAS DONE BECAUSE PEOPLE DIDN'T KNOW THEIR LIGHTS WEREN'T ON AT NIGHT, FORGOT TO TURN THEM OFF IF TH
