ON 3 SEPARATE OCCASIONS THE FAN BELT HAS COME OFF THIS VAN IN RAINY WET CONDITIONS. IT COULD HAVE CAUSED ACCIDENT IF I HAD NOT HAD GOOD UPPER BODY STRENGTH AND KNOW TO EXERT EXTRA FORCE TO STEER VEHICLE. THE FIRST INCIDENT OCCURRED AT 80,000 MILES . CHRYSLER DEALER REPLACED TENSION PULLEY AS IT WAS DIAGNOSED AS PROBLEM. IT OCCURED AGAIN AT 120,000 WITH TENSIONER PULLEY REPLACED AT ANOTHER AUTO REPAIR SHOP AND AGAIN AT 130,000 MILES.*AK
