ALSO HAD FUEL PUMP FAILURE IN CONJUNCTION WITH TRANSMISSION FAILURE W/IN THE FIRST YEAR TO YEAR AND A HALF OF OWNERSHIP OF THIS VEHICLE. THE DEALER CONTACTED CHRYSLER, BUT I WAS NOT ELIGIBLE FOR LEMON LAW COVERAGE. THEY DID EXTEND THE WARRANTY ON THIS LEASED VEHICLE. (DEALERSHIP) I HAVE NEVER FELT SAFE IN THIS VEHICLE, AND I CANNOT BELIEVE THAT WE PAID \$32500 FOR SOMETHING THAT IS ONLY WORTH LESS THAN \$10000 TODAY. CHRYSLER SHOULD BUY THESE VEHICLES BACK FROM PEOPLE, BUT THEY HAVE BEEN UNWILLING TO ASSIST.
