ENGINE AND CAR COMPLETELY SHUT DOWN ON 2 OCCASIONS (4/13/01 AND 7/27/01). MASS AIR FLOW SENSOR REPLACED INITIAL INSTANCE AND SOFTWARE UPDAED. IGNITION ND FUEL INJECTION FAULT TRACING. UNABLE TO ISOLATE CAUSE SECOND INSTANCE. INTERMITTENT COMMUNICATION FAULT AT ELECTRONIC THROTTLE MODULE. UNABLE TO DUPLICATE PROBLEM. REFUSE PICK-UP OF THE CAR AT ROYAL VOLVO SINCE VERY CONCERNED ABOUT SAFETY ISSUES. HAVE NOTIFIED VOLVO CUSTOMER SERVICES TWICE, VOLVO DEALERSHIP, NHTSA, OFFICE OF ATTORNEY GENERAL. THOROUGH LETTER BEING SENT TO NHTSA, CENTER FOR AUTO SAFETY, AND OFFICE OF ATTORNEY GENERAL ON 8/6/01. PLEASE THOROUGHLY REVIEW THE CONTENT.
