THEY'VE CONTACTED THE MANUFACTURER AND HAD THEIR STAR TECHNICIAN SUPERVISE THE LAST REPAIR, BUT THE PROBLEM STILL EXISTS. ON 12/3/1999 THE TECHNICIAN TEST DROVE WITH THE CUSTOMER TO DIAGNOSE NOISE IN STEERING COLUMN. ON 12/17/99, THE STEERING COLUMN WAS REPLACED. ON 12/23/99 A NOISE IN THE STEERING WAS FIXED WITH THE REPLACEMENT OF THE POWER STEERING LINES. ON 2/3/00, VEHICLE WAS CHECKED FOR RUBBING NOISE IN STEERING. THE TECHNICIAN COULD NOT DUPLICATE THE PROBLEM. ON 1/18/01, RACK AND PINION WAS ORDERED TO FIX

THEY'VE CONTACTED THE MANUFACTURER AND HAD THEIR STAR TECHNICIAN SUPERVISE THE LAST REPAIR, BUT THE PROBLEM STILL EXISTS. ON 12/3/1999 THE TECHNICIAN TEST DROVE WITH THE CUSTOMER TO DIAGNOSE NOISE IN STEERING COLUMN. ON 12/17/99, THE STEERING COLUMN WAS REPLACED. ON 12/23/99 A NOISE IN THE STEERING WAS FIXED WITH THE REPLACEMENT OF THE POWER STEERING LINES. ON 2/3/00, VEHICLE WAS CHECKED FOR RUBBING NOISE IN STEERING.
