ON ABOVE DATE THE CAR REVVED UP TO 4000 RPM BEFORE FINALLY ENGAGING AND I WAS ABLE TO PROCEED FROM THE STOP. WHEN THE CAR WAS TAKEN IN FOR SERVICING I DISCOVERED THAT THERE HAD BEEN A "SERVICE BULLETIN" MAILED TO DEALERS ABOUT THIS VERY PROBLEM. HONDA KNEW ABOUT THIS PARTICULAR PROBLEM AND NOT MADE IT PUBLIC. IF I HAD KNOWN THAT THIS WAS A SYMPTOM OF A FAULTY TRANSMISSION I WOULD HAVE CERTAINLY BROUGHT THE CAR IN. WHEN THE CAR WAS TAKEN IN FOR SERVICING I DISCOVERED THAT THERE HAD BEEN A "SERVICE BULLETIN" MAILED TO DEALERS ABOUT THIS VERY PROBLEM.
