NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE CHEVROLET ASTRO SHIFTS GEARS VIOLENTLY. THE PROBLEM WAS FIRST NOTICED AS I LEFT AN INTERSECTION AND THE VAN VIOLENTLY SHIFTED GEARS THROWING MY FAMILY'S AND MY HEAD BACK WITH EXTREME FORCE. THINKING THAT I HAD BEEN REAR-ENDED AND KNOWING THAT OTHER CARS WERE IN FRONT AND ALONGSIDE MY VEHICLE, I QUICKLY STEPPED ON THE BRAKE, ALMOST CAUSING A TRUE REAR-END COLLISION. THE VEHICLE WAS NOT IN WARRANTY SO I TOOK IT IN FOR INSPECTION BY MY LOCAL MECHANIC, WHO HAD PREVIOUSLY WORKED AS A SERVICE TECH FOR A CHEVY DEALERSHIP. HE WAS UNABLE TO FIND THE PROBLEM. HE CONTACTED ONE OF HIS FRIENDS WHO STILL WORKED AT THE CHEVY DEALERSHIP WHERE HE WAS FORMERLY EMPLOYED. MY MECHANIC TOLD ME THAT HIS FRIEND STATED THAT THE DEFECT WAS KNOWN BY CHEVROLET BUT THERE WASN'T ANY RECALL AND T
