IN THE PAST FOUR WEEKS WE HAVE REPLACED THREE OUT OF THE FOUR POWER WINDOW REGULATORS ON OUR 1993 NISSAN MAXIMA. THE POWER WINDOWS, ESPECIALLY IN THE REAR, GET VERY LITTLE USE. IT HAS COST OVER \$500 IN PARTS AND LABOR TO REPLACE THESE PARTS. INOPERABLE POWER WINDOW REGULATORS CAUSE A THREAT TO THE SAFETY OF THE VEHICLE AND ITS PASSENGERS.\*AK
