THE THEFT-DETERRENT ALARM GOES OFF FOR NO REASON WHEN PARKED AND LOCKED UP. THE OIL PRESSURE GAUGE MOVES ERATICALLY, DOME LIGHTS AND FLOOR LIGHTS COME ON BY THEMSELVE AND SOMETIME STAY ON FOR A LONG TIME AND SOMETIME CONSISTANTLY FLASH OFF AND ON, RADIO SHUTS OFF WHEN TURN ENGINE OFF(NOT SUPPOSE TO), AND CHECK ENGINE LIGHT CAME ON FOR A FEW DAYS THEN JUST WENT OFF. THE DEALER REPLACED THE BCM #9385236 BUT VEHICLE IS STILL NOT FIXED AFTER SEVERAL VISITS BACK TO DEALER.
