I KNOW FOR A FACT THAT OTHER 1996 JEEP CHEROKEES HAVE BEEN RECALLED FOR THIS SAME REASON AND I FIND IT APPALLING THAT ALL JEEPS WITH ROTOR PROBLEMS HAVEN'T BEEN RECALLED YET. WHAT IS IT GOING TO TAKE? A FATAL ACCIDENT, LIKE THE FIRESTONE ONES, FOR SOMETHING TO BE DONE. NO VEHICLE SHOULD BE EXPERIENCING THE SAME PROBLEMS WITH ROTORS EVERY TWO YEARS.
