THIS TRUCK HAS NOT BEEN USED TO TRANSPORT ANY HEAVY WEIGHT, JUST TO TRAVEL BETWEEN MY HOME IN SCOTTSDALE, AZ AND QUARTZSITE, AZ (A DISTANCE OF ABOUT 142 MILES). THE OTHER TIRES ON THE TRUCK (ALL THE SAME ORIGINAL TIRES THAT CAME WITH THE TRUCK) SHOW SIGNS THAT THEY ALSO MAY PEEL AND/OR SEPARATE.
