ORIGINAL AND 3 ADDITIONAL IGNITION COILS, CAPS, AND HARNESSSES CORRODED IN A 4 YR TIME SPAN. ORIGINAL AND TWO REPLACEMENT CATALYTIC CONVERTERS ALSO NEEDED TO BE REPLACED. MOST RECENT CATALYTIC CONVERTER WAS SO BADLY MELTED, TWISTED & DAMAGED THE MECHANIC STATED THAT I WAS "LUCKY" NOT TO HAVE THE ENTIRE ENGINE BLOWN. ALSO, HE NEVER SAW ANYTHING THIS BADLY DAMAGED IN HIS 25 YRS OF SERVICING MANY MAKES OF VEHICLES. THIS IS A 4 YR OLD VEHICLE AND IT SEEMS LIKE A TREND IS ESTABLISHED FOR REPLACING THESE SAME PARTS APPX. EVERY 17-20,000 MILES AND 10 MONTHS APART - JUST LONG ENOUGH THAT GM WILL NOT HONOR THE PARTS WARRANTIES. I DO DRIVE THIS VEHICLE LONG DISTANCES (300 MILES ONE WAY EACH WEEK TO A WORKSITE) BUT ALSO MAINTAIN IT TO THE MANUFACTURERS SPECS. I THOUGHT I BOUGHT A RELIA
