WHEN WE USE OUR TURN SIGNALS, THE EMERGENCY FLASHERS COME ON. THE FIRST TIME WE TOOK IT IN, THE DEALERSHIP FOUND NO PROBLEM. THEN THEY CHANGED A PART WHICH DID NOT SOLVE THE PROBLEM. THEY CLAIMED IT WAS AN "INTERMITTENT" PROBLEM AND WE HAD NO RECOURSE BUT TO BRING THE VEHICLE IN EVERY TIME THE PART MALFUNCTIONED. LAST NIGHT I WAS DRIVING WITH THREE CHILDREN IN MY VEHICLE ON A TWO LANE ROAD IN A RURAL AREA. AS I PREPARED TO TURN LEFT BY TURNING ON MY TURN SIGNAL I NOTICED A VEHICLE BEHIND ME TRAVELLING AT ABOUT 50 MPH. WHEN I SLOWED TO TURN, THE VEHICLE PASSED ME ON THE LEFT. HAD I NOT BEEN AWARE OF THIS PROBLEM, THERE WOULD HAVE BEEN A TERRIBLE ACCIDENT. IS MY JEEP THE ONLY ONE THAT HAS THIS PROBLEM. I GAVE UP ON TRYING TO HAVE IT FIXED TWO YEARS AGO BECAUSE I COULDN'T TAKE MY
