I HAVE BEEN IN ONE NEAR FATAL ACCIDENT ON THE HIGHWAY WHEN THE CAR LOST POWER GOING 70MPH, I HAD TO DRIVE OFF OF THE HWY SO THAT I WOULDN'T BE HIT FROM BEHIND, THEN MY HUSBAND HAS ALMOST BEEN IN ATLEAST 4 ACCIDENTS, WHEN THE CAR LOSES POWER WHILE TURNING ONTO A BUSY INTERSECTION (CAR STALLS IN THE MIDDLE OF THE ROAD). DEALER CAN'T SEEM TO FIND ANYTHING WRONG WITH THE CAR, YET I KEEP HAVING THE SAME PROBLEMS. I JUST GOT THE CAR BACK FROM THE DEALER THIS PAST FRIDAY, AND IT IS STILL STALLING OUT ON ME. IS IT GOING TO TAKE ME, OR ONE OF MY FAMILY MEMBERS, DYING IN THIS CAR TO
