TRANSMISSION FAILED. ONLY 2 WEEKS AFTER SPENDING NEARLY \$600 ON REPLACING THE FRONT AXLES, THE TRANSMISSION TOTALLY FAILED. I WAS DRIVING DOWN THE ROAD AT 35 MPH AND FELT A SLIGHT JERK. AFTER WHICH, THE CAR WOULDN'T KICK INTO GEAR. I MANAGED TO MAKE IT HOME, BUT WHEN I TRIED TO TAKE IT BACK TO THE SHOP, THE CAR WOULDN'T MOVE. I HAVE BEEN TOLD THAT THE CD4E TRANSMISSION WAS DESIGNED TO FAIL. I'VE BEEN TOLD THIS BY MULTIPLE PEOPLE, INCLUDING ONE EX-FORD MECHANIC. HE ALSO USED THE TERM "THROW AWAY CAR?!" I USUALLY GET RUDE LOOKS, OR LAUGHED AT WHEN I MENTION THAT I NEED A AUTOMATIC TRANSMISSION FOR A FORD PROBE. HELP ME! MY CAR HAS BEEN UNDRIVABLE FOR NEARLY 7 MONTHS.*AK
