MY PICKUP HAD A RECALL (#01021) TO CHANGE THE RECOMMENDED AIR PRESSURE . THE PRESSURE WENT FROM 55PSI IN THE FRONT AND 80 PSI IN THE REAR TO 35 PSI ON ALL TIRES. I CONTACTED FIRESTONE AND THEY TOLD ME THIS PRESSURE WAS UNSAFE AND THOSE TIRES SHOULD HAVE NO LESS THAN 58PSI. THE NEW STICKER MAKES NO MENTION OF INCREASING THE AIR PRESSURE IF A LOAD IS BEING CARRIED. THE RGWV FOR THAT TRUCK IS 6084 LBS, AND THE TIRES ARE EACH RATED TO CARRY 3042 LBS AT 80 PSI. A LOWER AIR PRESSURE DRASTICALLY REDUCES THE LOAD BEARING CAPABILITY OF THE TIRE, WHICH IS NOT ACCOUNTED FOR BY GMC. MY DEALER AGREES THAT THE PRESSURE IS TO LOW AND HAS RECOMMENDED I REMOVE THE TAG AND USE THE PREVIOUS RECOMMENDED PRESSURE. I AND THE DEALER HAVE CONTACTED GMC AND CAN GET NO ANSWER ON WA

MY PICKUP HAD A RECALL (#01021) TO CHANGE THE RECOMMENDED AIR PRESSURE . THE PRESSURE WENT FROM 55PSI IN THE FRONT AND 80 PSI IN THE REAR TO 35 PSI ON ALL TIRES. I CONTACTED FIRESTONE AND THEY TOLD ME THIS PRESSURE WAS UNSAFE AND THOSE TIRES SHOULD HAVE NO LESS THAN 58PSI. THE NEW STICKER MAKES NO MENTION OF INCREASING THE AIR PRESSURE IF A LOAD IS BEING CARRIED. THE RGWV FOR THAT TRUCK IS 6084 LBS, AND THE TIRES ARE EACH RATED TO CARRY 3042 LBS AT 80 PSI. A LOWER AIR PRESSURE DRASTICALLY REDUCES THE LOAD BEARING CAPABILITY OF THE TIRE, WHICH IS NOT ACCOUNTED FOR BY GMC. MY DEALER AGREES THAT THE PRESSURE IS TO LOW AND HAS RECOMMENDED I REMOVE THE TAG AND USE THE PREVIOUS RECOMMENDED PRESSURE. I AND THE DEALER HAVE CONTACTED GMC AND CAN GET NO ANSWER ON W
