I ALSO HAVE NOTICED GRINDING ON THE OUTSIDE OF THE CALIPERS CAUSING WORRY ABOUT THIS VEHICLES BRAKING SYSTEM. MY ROTORS CONTINUE TO WARP. GM WON'T DEFINE WHY THE CALIPERS ARE GRINDING ON THE OUTER SIDE WHEN ATLEAST A 1 INCH CLEARANCE AVAILABLE FOR ANY MOVING PARTS. *AK
