REGARDING COMPLAINT ON BATTERY: AT 26,000 MILES THE ORIGINAL BATTERY WAS REPLACED. THE REPLACEMENT BATTERY BEGAN LEAKING AT APPROX. 38000 MILES; HOWEVER, BATTERY DID NOT FAIL UNTIL 39000 MILES. DEALER SAYS SINCE BATTERY WAS REPLACED IN 36000 MILE PERIOD, THE REPLACEMENT BATTERY CARRIES NO WARRANTY. THIS DOESN'T MAKE SENSE. REGARDING HANDLES TO RECLINE SEAT BACK: THEY BOTH BROKE OFF WHERE CONNECTED TO CHAIR. SOFT METAL USED. THERE WAS NO HEAVY USAGE OR FORCE APPLIED. I FEEL THAT GM IS USING INFERIOR PARTS AND MATERIALS AND SEEK ASSISTANCE.*AK
