### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

VEHICLE WAS NOT BLOWING HEATED AIR. AFTER INITIAL ANALYSIS OF CLOSEST DEALER (FOX CHEVROLET - LAUREL MD.), IT WAS DIAGNOSED THAT ENGINE COOLANT HAD JELLED. I INSTRUCTED THEM NOT TO REPAIR DUE TO EXCESSIVE ESTIMATE TO FIX (AND PAID THEM THEIR EVALUATION FEE UNDER PROTEST), AND ARRANGED TO TAKE VEHICLE TO DEALER WHERE THE VEHICLE WAS PURCHASED. THEY DIAGNOSED THE HEATER CORE NEEDED TO BE REPLACED. PROBLEMS PERSISTED OVER THE NEXT MONTHS AND THE VEHICLE WAS RETURNED 3 ADDITIONAL TIMES. RUST AND/OR JELL IN THE SYSTEM DUE TO THE DEX-COOL COOLANT WAS CONTINUALLY DISCUSSED AS THE ROOT CAUSE AND THE SYSTEM HAD TO BE "BLOWN OUT" SEVERAL TIMES YET THE DEALER NOR THE MANUFACTURER WOULD TAKE ANY RESPONSIBILITY FOR THE COOLANT PROBLEM.
