CITY DRIVING) I DRIVE 100 MILES/DAY ON THE HIGHWAY FOR WORK. SOMETHING SHOULD BE DONE ABOUT THIS BRAKING PROBLEM BEFORE SOMEONE GETS HURT.\*AK
