THE IGNITION RECALL HAD ALREADY BEEN PREFORMED ON MY CAR PRIOR TO THESE PROBLEMS. THE FORD DEALERSHIP FOUND THE SWITCH BURNED, AND THE WIRING ASSEMBLY MELTED.*AK
