BRAKES ENGAGING AND OVERHEATING ON THE FREEWAY, INTERMITTENTLY; THIS MAY AFFECT THE ABILITY TO STOP QUICKLY ENOUGH IN AN EMERGENCY. DETAILS: SINCE THE BRAKES WERE FIRST SERVICED AT JUST UNDER 4,000 MILES, THERE IS A CONTINUING PROBLEM WITH THE BRAKES RANDOMLY ENGAGING BY THEMSELVES ON THE FREEWAY. WHEN THIS HAPPENS, IT IS NOT SUFFICIENT TO CAUSE THE VEHICLE TO STOP, BUT THE CAR AT TIMES WILL LABOR TO MAINTAIN SPEED. THE CAR ALSO PRODUCES A LOW PITCH HUMMING SOUND AND A STIFF VIBRATION (SHIMMY) IN THE STEERING WHEEL. THE BRAKE PEDAL PULSATES WHEN BARELY TOUCHED (AT THE TIME THIS PHENOMENON IS OCCURRING). AFTER A NUMBER OF MILES THE SYMPTOMS DISAPPEAR. THE FREQUENCY OF THIS EVENT IS ABOUT ONCE EVERY 100 TO 200 MILES. I BELIEVE THE HUMMING, STEERING WHEEL VIBRATION
