TO MY KNOWLEDGE, THE AUTOMATIC TRANSMISSIONS LINKED TO THE 3.0 V6 OF THE ACURA CL AND HONDA ACCORD HAVE BEEN GIVING NUMEROUS HONDA CUSTOMERS PROBLEMS. THE TRANS. HAS BEEN SHIFTING ABRUPTLY AND INTO INAPPROPRIATE GEARS FOR SOME TIME. THIS IS POTENTIALLY HAZARDOUS DUE TO THE FACT THAT I NEARLY TOTALED MY ACURA WHILE TRYING TO PASS A SLOW MOVING VEHICLE AND THE TRANSMISSION MALFUNCTIONED DURING THIS ATTEMPT AT PASSING. I NEARLY COLLIDED WITH ON COMING TRAFFIC. MY CAR IS CURRENTLY IN THE SHOP FOR THIS PROBLEM AND HAS CAUSED ME TO HAVE TO REBUILD THE TRANSMISSION BECAUSE I CANNOT AFFORD THE COST OF A NEW REPLACEMENT FROM THE FACTORY.
