WARPED FRONT ROTORS REPLACED FOR THIRD TIME AT 35000 MILES. CHEVY HAS COVERED THE REPAIRS BUT WILL NOT PROVIDE EXTENDED WARRANTY COVERAGE. THEY STATE THAT THIS IS THE EXPECTED LIFE FOR ROTORS (APPROXIMATELY 12000 MILES) BASED ON LOCAL DRIVING CONDITIONS. ROTORS ON MY PREVIOUS CARS HAVE LASTED 40000 MILES OR MORE. I FOUND DOZENS OF SIMILAR COMPLAINTS IN THE DATABASE. THERE SEEMS TO BE A GENERAL PROBLEM WITH THE BRAKE SYSTEM THAT CHEVY SHOULD RECOGNIZE AND CORRECT BEFORE THE FAULTY BRAKES CAUSE ACCIDENTS. I SHOULD NOT HAVE TO PAY FOR NEW ROTORS EVERY 12000 MILES.\*AK
