VEHICLE HAS NOT BEEN ABUSED OR INVOLVED IN ANY SORT OF COLLISION, AND MANUFACTURER'S RECOMMENDED SERVICE HAS BEEN PERFORMED AT INDICATED INTERVALS. THIS IS AN USUSUAL PART TO FAIL AT THIS MILEAGE AND UNDER THESE CIRCUMSTANCES. REVIEW OF USENET INTERNET NEWSGROUPS INDICATES THAT PREMATURE FAILURE OF THIS PART IS WIDESPREAD AND WELL-KNOWN TO DEALERS. APPARENT CAUSE IS INHERENT WEAKNESS IN THE ORIGINAL DESIGN, NOW SUPPLANTED BY A STRENGTHENED DESIGN IN THE REPLACEMENT PART - WITH NO ADMISSION OF RESPONSIBILITY BY MANUFACTURER FOR DESIGN FLAW IN THE ORIGINAL.\*AK
