THE ABS SYSTEM ON THIS VEHICLE HAS HAD MANY PROBLEMS SINCE NEW. MANY TIMES THE BRAKING SYSTEM WOULD PULL TO ONE SIDE AND THIS IS DOCUMENTED IN REPAIR ORDERS AT THE DEALER. DEALER NEVER WAS ABLE TO FIND A PROBLEM AT THE TIME OF THE RO. IN 1996 DEALER REPLACED ABS RELAYS TO CORRECT CONCERNS OF ABS SYSTEM INOPPERABLE. THE ABS WARNING LIGHT HAS COME ON MANY TIMES. DEALER NOT ABLE TO DETERMINE ANY PROBLEM. THEN DURING JULY AND AUGUST OF 2000 MORE CONSISTANT PROBLEMS BEGAN TO OCCUR. VERY BAD PULL TO ONE SIDE UPON BRAKING ON ONE OCCASION AND A STIFF PEDAL WITH GREATLY REDUCED BRAKING EFFECTIVENESS. TOOK TO DEALER FOR THESE PROBLEMS, RO STATES RED BRAKE LIGHT AND YELLOW ABS WARNING LIGHTS COME ON AND STAY ON. REPLACED ACCUMULATOR. LEFT DEALER AND WITH IN BLOCKS WARNING LIGHT
