I HAVE LOST 24 HOURS EACH TIME I BRING THE JEEP FOR SERVICE. THE DEALER/MANUFACTURE DOES NOT SEEM TO BE ABLE TO REPAIR THIS PROBLEM. THE DEALER/MANUFACTURE DOES NOT SEEM TO FEEL THE PROBLEM IS IMPORTANT OR SERIOUS. I UNDERSTAND THAT ONLY ABT 70% OF AMERICANS ARE USING SEAT BELTS AND HARNESS'S. SEEMS IMPORTANT ENOUGH TO ME.
