I HAVE HAD MULTIPLE FAILURES OF THE FRONT RACK AND PINION STEERING GEAR AND RELATED COMPONENTS. EACH REPAIR HAS LASTED AN ESTIMATED 12,000 MILES UNTIL RETURNING. THE SYMPTOMS ARE A BANGING NOISE AT LOW SPEEDS WHILE TURNING WITH SOME LOSS OF CONTROL. DURING THE LAST FAILURE PERIOD, I ALLOWED THE SITUATION TO CONTINUE TO SEE IF IT WOULD WORSEN AND IT INDEED HAS. THE PRESENT ESTIMATE FROM THE DEALER TO REPAIR THE PROBLEM IS \$1,500. PREVIOUS REPAIRS HAD BEEN DONE UNDER WARRANTY. I DRIVE AN AVERAGE OF 500 MILES PER WEEK AT HIWAY SPEEDS AND AM GREATLY CONCERNED ABOUT MY SAFETY.*AK
