I HAVE EXPERIENCED CHRONIC PROBLEMS WITH THE FRONT ROTORS ON MY CAR. I HAVE FELT PULSATION WHILE BREAKING AT REGULAR 6 MONTH INTERVALS AND HAVE HAD TO REPEATEDLY BRING THE CAR IN FOR SERVICE TO REMEDY THIS PROBLEM. SPECIFICALLY, THE ROTORS HAVE BEEN RESURFACED EVERY 6000 MILES AND REPLACED EVERY 12000 MILES. THIS HAPPENED AT 12,000, 18,000, 24,000, 30,000 AND NOW AT 36,000 WHEN THE DEALER SUGGESTS THAT I REPLACE THE FRONT AND REAR BRAKES AND ROTORS. INITIALLY I RECIEVED SOME ASSISTANCE FROM THE DEALER WITH THE ROTORS RESURFACED TWICE AND REPLACED ONCE AT THEIR EXPENSE, BUT NOW THEY ARE CLAIMING NO FURTHER RESPONSIBILITY AND HAVE EVEN SUGGESTED THAT THIS MAY BE MY DRIVING THAT IS CAUSING THE PROBLEM. SEEING HOW MANY SIMILAR COMPLAINTS THERE ARE ON THE INTERNET, I HIGH
