TOOK TO COUNTRY CHEVROLET IN WARRENTON, VA-ADVISED OF 4WD PROBLEM ALSO ADVISED CHECK ENGINE LIGHT COMES ON, HEADLIGHTS DIM OCCASSIONALLY WHEN DRIVING. IN ADDITION, WHEN ENGINE IS TURNED OFF AND RADIO REMAINS ON, BATTERY DIED 2 TIMES. MECHANIC FOUND CIRCUIT 1133 SHORTED TO STEERING COLUMN BRACKET, REPLACED WIRE. PROBLEM REOCCURRED IMMEDIATELY. RETURNED TO COUNTRY CHEV-RECHECKED AND REPLACED WIRING. 4WD LIGHTS STILL FLASH. UNABLE TO DETERMINE TROUBLE.*AK
