DRIVERS SIDE SEAT, RIGHT POWER SEAT MOUNT IS BROKEN. IN THE EVENT OF A CRASH SEAT WILL NOT BE RETAINED. SEARCH FOR A REPLACEMENT INDICATED THAT OTHER LIKE VEHICLES ARE ALSO SUFFERING CRACKS IN THE SAME PART. THE FAILURE OF THE PART WILL CAUSE THE SEAT TO NO LONGER SUPPORT THE DRIVER IN THE EVENT OF A CRASH POSSIBLY RESULTING IN SERIOUS INJURY. MULTIPLE VEHICLES WITH THE SAME PROBLEM INDICATE THAT THIS IS NOT AN ISOLATED INCIDENT AND THERE IS A DESIGN DEFECT IN THE PART.
