A WEEK LATER THE SAME THING HAPPENED TO THE BACK WINDOWS. WE TOOK THE CAR IN FOR SERVICE AND ALL THEY TELL US IS THAT THEY CANNOT REPRODUCE THE PROBLEM. THEREFORE THEY FEEL THAT THERE IS NOTHING WRONG. I HAVE HAD BRAKE FAILURE 4 TIMES ON THIS CAR. THEY HAVE CHANGED THE MASTER CYLINDER 2 X'S. ARE REFUSING TO DO ANYTHING ELSE AT THIS TIME. THEY SAY THE CAR IS OKAY. *AK
