VEHICLE PARKED IN GARAGE ATTEMPTED TO START ITSELF AT 6:01AM (MDT). KEY WAS NOT IN IGNITION NOR WAS IGNITION SWITCH ENGAGED. VEHICLE CRANKED FOR APPROX. 4 MINUTES WHILE OWNER ATTEMPTED TO DISCONNECT BATTERY. FOLLOWING APPROX 4 MINUTES OF ENGINE CRANKING VEHICLE STOPPED ON ITS OWN. OWNER THEN ATTEMPTED TO START VEHICLE TO MOVE OUT OF GARAGE IN THE EVENT OF ANOTHER OCCURRENCE. VEHICLE ELECTRICAL SYSTEM WAS COMPLETELY SHUTDOWN AND VEHICLE WOULD NOT START. OWNER ALSO NOTICED STRONG ELECTRICAL BURNING ODOR. VEHICLE WOULD ALSO NOT DISENGAGE FROM PARK DUE TO TOTAL SYSTEM FAILURE. VEHICLE WAS TOWED TO DEALER.
