REGARDING THE FRONT SUSPENSION. THE CAR SHIMMIES AND THE STEERING IS LOOSE (STEERING WHEEL SHACKS IN YOUR HANDS). HAD FRONT END ALIGNMENT DONE BUT THIS DID NOT FIX THE PROBLEM. CONTEMPLATING NEW TIRES BUT SEE OTHERS WITH SIMILAR PROBLEMS AND THIS DID NOT CORRECT THE PROBLEM.*AK
