WINDSHIELD WIPERS & WASHER SPRAY INTERMITTENTLY WOULD STOP WORKING, BUZZ SOUND FROM MOTOR HOUSING. TYPICALLY I COULD GET TO START AGAIN BY HITTING BLACK COVER OF WIPER MOTOR. I TOOK OFF COVER AND DETERMINED THE CONTROL CIRCUIT BOARD FAILED, PROBABLY THE RELAY. I PURCHASED NEW BOARD AND WORKS FINE. I NOTIFY NHTSA FOR 2 REASONS & THINK SHOULD BE RECALL. 1) NEW PART INDICATES NEED TO SEAL COVER, ORIGINAL NOT SEALED 2) FRIEND HAS SAME YEAR CHEVY K2500 & HAS IDENTICAL PROBLEM. SUSPECT MAY BE DUE TO NORTHEAST WEATHER CONDITIONS AND DEFECT IN DESIGN.*AK
