I AM NOW PLANNING TO TRANSPORT THE VEHICLE TO FLORIDA AND DIRVE IT ON OCCASION. I WAS NOTIFIED OF THIS RECALL IN 1983 AND HAVE MISPLACED THE NOTIFICATION DUE TO THE CAR BEING IN STORAGE. I WOULD APPRECIATE ANY ASSISTANCE IN GETTING THIS RECALL DONE, WORKING WITH A DEALER NEAR WHERE IT IS STORED IN BURLINGTON, VERMONT. THEY SAY THEY HAVE NO ACCESS TO OBTAINING THIS INFORMATION AND UNLESS I CAN PROVIDE THE NOTICE, THEY ARE UNABLE TO HELP ME.
