STOPPED AT RED LIGHT WITH LEFT TURN SIGNAL ON. TURN SIGNAL INDICATOR ON DASH WENT DIM, BUT NOT OUT COMPLETELY. A FEW SECONDS LATER SMOKE STARTED COMING OUT FROM THE TOP OF THE STEERING COLUMN AROUND THE OPENING FOR THE HAZARD LIGHT ACTIVATION SWITCH. SHUT OFF THE ENGINE, PUSHED TRUCK OFF TO THE SIDE; WAITED ABOUT 15 MINUTES, STARTED BACK UP, NO FURTHER INDICATION OF PROBLEM (HOWEVER, DID NOT USE TURN SIGNALS AGAIN FOR REMAINDER OF TRIP: ~5 MILES). *AK
