IT TOOK SOME TIME BEFORE I COULD DETERMINE THE SOURCE OF THE SQUEAK BECAUSE IT WAS AN INTERMITTENT PROBLEM. THE OEM PITMAN ARM IS A SEALED UNIT WITH INSUFFICIENT LUBRICATION & NO PROVISION FOR LUBRICATION. THIS IS A STEERING COMPONENT & SHOULD BE RECALLED. ALL STEERING & SUSPENSION MOVING COMPONENTS SUCH AS TIE-ROD ENDS & BALL JOINTS SHOULD BE REQUIRED TO HAVE PROVISIONS FOR LUBRICATION. MY VEHICLE HAS BEEN REPAIRED BUT I HAVE OBSERVED SEVERAL VEHICLES OF THE SAME MODEL WITH THE SAME PROBLEM DURING PARKING LOT TURNS. THIS IS A STEERING COMPONENT & SHOULD BE A SAFETY RECALL, NOT A TSB. THERE IS NO SAFE SUBSTITUTE FOR PROPER VEHICLE MAINTENANCE, NO MATTER WHAT THE MANUFACTURERS TELL YOU ABOUT SEALED COMPONENTS. MOVING PARTS WITH GREASE FITTINGS ARE SEALED ALSO. IF I
