WHEN DRIVING AND SHIFTING FROM 3RD TO 4TH GEAR TRANSMISSION ENGAGED 2ND GEAR. THIS CAUSED THE ENGINE REV BEYOND NORMAL LIMITS. THE ENGINE DIED, AND HAD TO BE TOWED TO LOCAL ACURA DEALER. EXTENSIVE ENGINE DAMAGE WAS REVEALED. ACURA IS DENYING WARRANTY CLAIM. MANY OWNERS ARE HAVING THE SAME PROBLEM. ONE CASE AT BALL ACURA IN NATIONAL CITY, CA IN SEPTEMBER WAS WARRANTIED UNDER THE EXACT SAME CIRCUMSTANCES. ANOTHER CASE AT ACURA WOODBINE IN ONTARIO CANADA WAS WARRANTIED FOR THE SAME PROBLEM DURING THE FIRST WEEK OF SEPTEMBER. ACURA HAS A PROBLEM WITH THIS VEHICLE, YET THEY WILL NOT WARRANTY MY VEHICLE. THIS IS UNFAIR. PLEASE INVESTIGATE.
