ON MY WAY HOME FROM WORK ON SEPT. 21, 2001, I HAD TO SIT ON I-435-E. FREEWAY FOR AN HOUR BECAUSE OF A CAR ACCIDENT. I WAS MOVING NO MORE THAN 5 TO 10 MILES AN HOUR. WHEN I GOT TO I-71-N AND I TOOK I-71 TO THE LINWOOD EXIT GOING 55 TO 60 MILES AN HOUR AND THEN 45 TO 50 MILES AN HOUR AND THEN 55 TO 60 AND THEN 45 TO 50. I EXITED LINWOOD TO THE EAST, OVER TO INDIANA (LINWOOD IS THE 32ND HUNDRED BLOCK). I WENT SOUTH ON INDIANA TO 3318 INDIANA. I PARKED MY CAR AND WENT IN THE HOUSE. I WAS IN THE HOUSE ABOUT 2 TO 3 MINUTES BEFORE MY NEIGHBORS CAME TO MY DOOR AND SAID MY CAR WAS ON FIRE. THEY WERE USING THEIR WATER HOLES TO PUT OUT THE FIRE.
