THE VEHICLE HAD A WIRING FAILURE TWICE SINCE I OWN IT. THE FIRST FAILURE APROXIMATELY 65000, AND THE SECOND FAILURE AT APROX 89000. I TROUBLESHOOTED THE PROBLEM AND AFTER DISASSEMBLING ALMOST THE COMPLETE DASHBOARD FOUND 3 WIRES CHAFFING AGAINST A METAL STANDOFF UNDERNEATH THE PASSENGER'S AIRBAG ABOVE THE A/C BLOWER MOTOR. THIS WIRING HAD NO PROTECTION IN THIS TIGHT AREA. THIS COULD VERY WELL START AN ELECTRICAL FIRE ON THE CAR. I FEEL IS MY RESPONSIBILITY TO INFORM YOU IN THE EVENT THIS COULD BE A POTENTIAL PROBLEM IN THIS TYPE OF VEHICLE.*AK
