### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ALL THREE OF THE REAR SEATBELTS WILL NOT RETRACT. I TRIED TO PUT A CHILD RESRAINT SEAT IN THE LEFT REAR SEAT, I PULLED THE BELT ALL THE WAY OUT AS MY TOYOTA MANUAL SAYS TO DO IN ORDER TO LOCK THE CHILD SEAT INTO PLACE AND THE BELT WOULD NOT FEED BACK INTO THE RETRACTER. I THEN TOOK THE SEAT OUT AND PUT IT IN THE RIGHT SIDE AND THE SAME EXACT THING HAPPENED. THAT WAS IN MAY 2001. A FEW DAYS AGO THE MIDDLE SEAT BELT DID THE SAME THING, LEAVING MY CHILD WITH NO SEAT BELT IN THE BACK AND MY ONLY OPTION IS TO PUT HIM IN THE FRONT SEAT WHICH IS NOT SAFE EITHER. I HAVE CONTACTED THE DEALER AND THE MANUFACTURER OF TOYOTA AND HAVE BEEN TOLD THAT MY CAR IS NO LONGER UNDER WARRANTY AND IT WILL COST ABOUT \$190.00 PER SEAT BELT TO GET THEM REPLACED. I DO NOT HAVE THAT KIND OF MONEY AND FEE
