### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ALL 1999 HARLEY DAVIDSON "TWIN CAM" ENGINES WERE EQUIPPED WITH FAULTY CAM BEARINGS WHICH WERE CHANGED DURING THE 2000 MODEL YEAR. BASED ON PERSONAL KNOWLEDGE THE NOISE WHICH THE ENGINE MAKES UPON FAILURE OF THE CAM BEARING CAN CAUSE THE OPERATOR TO PANIC OR REFLEXIVELY KILL THE ENGINE AT SPEED AND CAUSE A CHIAN REACTION COLLISION. THERE IS LITTLE OR NO WARNING BEFORE A TERRIBLE SOUND IS EMITTED FROM THE EGINE AND THE ENGINE LIGHT IS ILLUMINATED. THE NOISE AND ITS INTERFERENCE WITH THE OPERATORS ATENTION ALONE CAN CAUSE A LOS OF CONTROL WITH ATTENDANT INJURIES TO RIDERS OR BYSTANDERS. IN A JANUARY 22, 2001 LETTER TO PURCHASERS HARLEY DAVIDSON MOTOR COMPANY ACKNOWLEDGED THE PROBLEM BUT DECLINED TO RECALL ALLEGING (1) THAT THE FAILURE HAD ONLY OCCURRED IN "A SMALL
