### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

FIRST FAILURE WAS ON A ROAD AT 20 MPH IN A SCHOOL ZONE ON A RAINY DAY. APPLIED PRESSURE TO THE BRAKES AND THE BRAKE PEDAL WENT ALL THE WAY TO THE FLOOR WITHOUT THE CAR STOPPING. CAR ADVANCED 3-5 FEET BEFORE I REALIZED MY FOOT WAS ON THE BRAKE PEDAL AND THEY WERE NOT WORKING. I APPLIED PRESSURE TO THE BRAKES AGAIN AND THE CAR CAME TO A COMPLETE STOP. BRAKES APPEARED TO WORK AT THE NEXT COUPLE OF STOPS. PULLED INTO PARKING SPACE AND PARKED CAR. BRAKES APPEARED TO BE WORKING FINE. PULLED OUT OF PARKING SPACE. BRAKES APPEARED TO BE WORKING WHILE BACKING OUT. PROCEEDED TO INTERSECTION AT ABOUT 5 MPH. APPLIED PRESSURE TO BRAKES AND THEY DID NOT WORK. MY VEHICLE PROCEEDED INTO INTERS
