FORTUNATELY, IT WAS 3:30 AM AND NO TRAFFIC. I WAS ABLE TO SWING INTO AN EMPTY PARKING LOT AND CIRCLE UNTIL THE CAR CAME TO A STOP. UPON TALKING TO SEVERAL OTHER ALLANTE OWNERS, I FOUND OUT THAT THIS IS A FREQUENT OCCURANCE WITH THESE CARS. DOES SOMEONE HAVE TO BE KILLED BEFORE CADILLAC DOES SOMETHING ABOUT THIS POTENTIALLY FATAL FLAW?"AK
