I RECEIVED THIS 2001 BEETLE AFTER SPEAKING WITH THE DEALERSHIP AND A VOLKSWAGEN REPRESENTATIVE, BECAUSE MY 2000 BEETLE HAD SO MANY PROBLEMS WHICH COULD NOT BE FIXED. AFTER ABOUT 5 MONTHS, THIS 2001 BEETLE HAS HAD MANY PROBLEMS AND CONTINUES TO HAVE MANY PROBLEMS. I TOOK IT IN THE FIRST TIME ON JULY 26, 2001 FOR ENGINE PROBLEMS. THE DEALERSHIP THAT I TOOK IT TO FOR SERVICE SAID IT WAS A DEFECT AND THEY ORDERED ME PARTS TO CORRECT THE PROBLEM. THEY DID ALSO FIND FAULTS WITH P1200 AND P0411 TECH BULLETINS. IT WAS ALSO DISCOVERED THAT THE SECONDARY AIR INJECTION PUMP MOTOR WAS INOPERATIVE. THEY REMOVED AND INSTALLED AN OVERRUN CUT-OFF VALVE. THAT SAME DAY, THE WINDOW GLASS WAS F
