THE TRUCK WOULD STALL UNEXPECTEDLY DURING COLD WEATHER RUNNING. THE PROBLEM BEGAN APPROXIMATELY TWO YEARS AFTER MY PURCHASE. THE PROBLEM WAS DIAGNOSED AS AN IGNITION MODULE WHICH WAS REPLACED, BUT I WAS NOT CONVINCED THAT WAS THE ENTIRE PROBLEM. THREE MONTHS LATER IT OCCURRED AGAIN ON A ROAD TRIP. PRIOR TO THE TRIP FROM SALT LAKE CITY TO CANADA, I WROTE A LETTER TO THE V.P OF CUSTOMER COMMUNICATIONS AND SATISFACTION EXPLAINING THE DANGER OF THE SAME COMPONENT FAILURE IF ONE WERE TRAVELING ON A REMOTE HIGHWAY IN A COLD ENVIRONMENT. I EXPLAINED THAT ONE COULD DIE OF HYPOTHERMIA AND SUGGESTED THEY FIND THE REAL CAUSE OF THE PROBLEM. THEY REFUSED. MY FORESIGHT WAS EXACTLY
