MY WIFE STARTED VEHICLE IN GARAGE (ENGINE COLD). SHE PLACED IN REVERSE AND STARTED BACKING INTO DRIVEWAY. VEHICLE SUDDENLY LUNGED BACKWARD, ENGINE RACING. MY WIFE TRIED UNSUCCESSFULLY TO STOP THE CAR WITH THE BRAKES, BUT THE VEHICLE WAS ACCELERATING TOO RAPIDLY. JUST BEFORE SHE RAN OUT OF DRIVEWAY, SHE PLACED THE TRANSMISSION IN PARK AND SHUT OFF THE ENGINE. LAND ROVER BROUGHT IN A TECHNICIAN WHO KEPT THE CAR TWO DAYS, RUNNING TESTS. THEY RETURNED THE CAR TO US HAVING ADJUSTED SOMETHING ON THE BRAKES TO MAKE SURE THEY WERE WORKING PROPERLY (WHICH THEY ALREADY WERE). THEY TOLD US THEY WERE UNABLE TO FIND ANY PROBLEM THAT COULD HAVE CAUSED THE SUDDEN ACCELERATION. WE WE
