I AM THE OWNER OF A 1999 KIA SEPHIA, WHICH I PURCHASED BRAND NEW IN AUGUST OF 99. AT 14,843 MILES, I EXPERIENCED SERIOUS PROBLEMS WITH THE BRAKES. WHEN THE BRAKES ARE APPLIED AT 35 MPH, THE FRONT OF THE CAR AND THE STEERING WHEEL WOULD SHAKE OUT OF CONTROL WHEN COMING TO A STOP. THE BRAKE PADS AND ROTORS WERE REPLACED AT 14,843, BY A CERTIFIED KIA MECHANIC. SOON AFTER, ON A SEPARATE OCCASION, MY VEHICLE WAS BROUGHT IN FOR REPAIRS TO THE SAME MECHANIC FOR THE SAME PROBLEM. IN JULY OF 2001, I EXPERIENCED THE SAME PROBLEM FOR THE 3RD TIME. THE VEHICLE WAS BROUGHT IN FOR REPAIRS TO THE SAME KIA MECHANIC AND THE PADS WERE REPLACED. ON 25 OCT 01, I BROUGHT MY CAR IN AGAIN TO THE SAME KIA MECHANIC TO TEM
